It is NOT appropriate to approach the Co-chairs, secretariat staff, or any other people on the podium to request an intervention. Major Groups interventions are solely coordinated through the Organizing Partners. Given high demand for intervention, especially within the NGO Major Groups, interventions are not guaranteed and we highly recommend you contact your organizing partners ahead of the meeting to coordinate.
