You are registered to attend the following meeting:

Thirteenth Session of the Open Working Group on Sustainable Development Goals to be held from 14 – 18
 July 2014 in Conference Room 3, Conference Building, UNHQ.

Please be aware that UN Headquarters is currently undergoing renovation, and so extra time may be required to arrive and check in at meetings during this period.

I. Coordination for participants

The sustainable development process convened under the UN adheres to a format known as Major Groups. This innovative structure relies on the voluntary service of facilitators, or organizing partners, for each of the nine Major Groups sectors.

II. Meeting details

Please familiarize yourself with the venue and instructions for arrival and check-in, and be sure to leave sufficient time to collect passes if necessary. The following are the particulars on acquiring a special event pass to attend OWG 13. Please familiarize yourself with them prior to arrival to ensure you are able to enter the meeting in a timely fashion. Note that passes will **NOT** be distributed outside of the designated times.

II. Pre-travel

Please note that your organization will need to make arrangements to cover the cost of your travel to and from New York, as well as your accommodations during the meeting. Please also ensure that you have the necessary visa for entry into the United States through your local US Embassy or Consulate. Representatives requiring a visa to enter the United States are advised to apply as early as possible in case any time is needed for special clearances by the US authorities, and ensure that the visa is received in time for travel. Past practice shows that when applying for a US visa, it is recommended that NGOs and other representatives of major groups bring copies of the UN confirmation letter, as well as a letter prepared by their own NGO, at the time of their appointment with the US Consulate or Embassy. The NGO letter should include detailed information on the visa applicant (e.g., position, number of years working for the NGO, and number of applicants that the NGO is sending to the event).

III. Admission of Non-United Nations Personnel

Pre-registered participants with a valid UN annual grounds pass (N-pass) can proceed directly to the venue on the day of the meeting after being screened by security. Pre-registered participants without an annual grounds pass will be met by security and our staff at the visitor's entrance located at 1st avenue and 47th Street, where they will receive their event pass before being screened by security. Please be sure to bring your original confirmation letter to ensure that you are provisioned a pass. Please be sure to note the times during which you can pick up your passes – if you cannot pick up passes at these times, contact the Secretariat. We will NOT be able to accommodate last minute requests.

IV. <u>ECOSOC NGOs – Request for 2014 UN Grounds Passes</u>

Please follow the detailed guidelines for requesting a UN grounds pass available at: http://csonet.org/?menu=86. As always you will need a letter on official letterhead. Annual passes will be issued from **2 January 2014** onwards. The process is entirely online. Procedures for Geneva and Vienna remain unchanged. http://csonet.org/?page=view&nr=152&type=230&menu=14

Policies during the OWG

For OWG 13, we will have to apply the GA Resolution A/67/L.48/Rev.1 OWG on SDGs para 8 which states that:

The following may participate as observers in the meetings of the Open Working Group in the manner outlined in ECOSOC decision 1993/215:

- i. Representatives of Specialized Agencies and related organizations; and
- ii. Representatives of non-governmental organizations in consultative status with ECOSOC

This means that organizations without ECOSOC-status will have to seek sponsorship from those that have ECOSOC-status. Please contact with the appropriate OPs prior to the session to make the necessary arrangements should you desire to make an intervention.
