**COMMUNITY AND FAMILY AID FOUNDATION (NGO)** is a Ghanaian National Non-Governmental Organization with a global thinking and acting locally, currently exclusively identified with promoting the empowerment of women, communities, young people to manage issues concerning their development and to advocate for and work towards adolescent and sexual reproductive health, rights and well-being; to advocate for and on behalf of young people, in the area of reproductive health, HIV/AIDS, environmental health education, climate change, and other related issues that affect their total development. Aim at hosting the largest effort of reaching out to youth of Ghana to appreciate and respond to their sexual health rights needs for a bright future and promoting their development toward the nations building.

CAFAF is registered under Registration Act 1963 No 21446 founded in 2006; the organization is also registered under the social welfare system DSW NO 3692. The work of CAFAF has spread over the entire Accra-region, has determined to organize the various programmes for the better livelihood, protection and sustainable development. CAFAF is working in the field of Integrated Rural Development, HIV/AIDS/maternal health, sexual reproductive health, promotion of Traditional Health System and Involvement and Advocacy for the social issues having a definite bearing on the life of people.

CAFAF has come forward with a strong faith that its efforts will uplift the socio economic condition of those people who have been neglected and denied for their rightful share of the society for centuries. The Organization work jointly with the people inviting them to participate actively in solving their own problems, The Organization support their reasonable demand and decision and encourage them to discover and utilize the available natural resources. CAFAF trusts that the spread of education will help them to overcome their deep rooted superstitions and social evils regarding emerging trends.

#### THE ANNUAL GENERAL MEETING

The Annual General Meeting (AGM) accordingly and by our constitution and policies remains the highest decision making body which looks into the overall operations and mandates of the organization. It is conveyed yearly and when the need arise equally tasked to meet for emergency to undertake critical decisions on key issues prevailing at the time. It brings together on one platform both dues and none paying dues members. This kind of encounter is set to review, act, and appraise the general performance of the management of the organization. Aftermath of satisfactory of the works of the management their contract is extended to another period agreed upon. Therefore the AGM is the heart beat of the foundation for which reason their decisions is central in the affairs of the organization.

#### **EXECUTIVE MANAGEMENT**

Beyond the operations of the AGM comes the executive management team led by a nucleus constituted set of expertise that are mandated to put the decisions of the AGM into action. They convey a series of meetings during which both financial and narrative activities reports..Are presented for thorough review by members. Thus, the executive management operates the organization for and on behalf of the members of the AGM. The chairman elected at the biannual AGM is expected to play active role and be the mouth piece of the AGM in the administration of the foundation all the time in the day to day running of the foundation.

Additionally, the Executive Director, is expected to expand the administration pattern of the organization and when necessary to make running of the secretariat smooth upon consultation with the chair person in the cause of time. The members of staff and volunteers is unlimited for which reason the Executive Director takes into accounts the available resources ,needs, projects, situation vacant before recruiting people into the organization.

#### THE SECRETARIATE

The Secretariat is managed with the support of core staffs and the chairperson of the foundation. The Executive Director supervisors and coordinates all activities that take place from administration to other forms of engagement. Refer to our administrative documents for details. The secretariat is also mandated to venture into other key activities when necessary to the extent of having the power to open offices in other regions should the need be and where the resource for implementation of projects are available to do so.

**INTERNATIONAL OFFICES:** CAFAF by its constitution is free to operate foreign policy advocacy service across the globe. In this vain management is expected to follow the due processes in securing the necessary permits to operate at such levels. In 2013 quiet a number of people approached the foundation seeking permission to open similar offices outside the country to articulate the mission and vision of the foundation at such levels. Such permission has been granted to a group in Kenya and management is in constant touch with them supporting them to put the necessary structures in place. Outcomes of such engagement will be communicated into our next report in the coming years.

These offices are not to rub shoulders with the mother organization rather play complementary role in making the voice of people count through policy influence.

#### **REGIONAL FOCAL POINT**

CAFAF in the future hopes to operate in other regions in Ghana. As per our constitution management is in consultation with other Networks with possibility of opening office in a region that we are likely to begun implementing activities there. Such offices will be mined by regional representatives with core staff and volunteers where necessary. They will be expected to report to the regional office depending on the type of activities and projects offered on the grounds.

**MEMBERSHIP:** The organization recognizes two sets of members; they include direct and indirect members.

**DIRECT MEMBERS: They** are individuals and organizations who have interest in the organization. Such members pay dues and are engaged in most of the activities of the foundation as and when time will allow them. They are given specific tasks and targets to achieve which is supervise by a senior management member. These volunteers' members also represent the foundation at different levels of interaction and are mandated to raise funds to boost the operations of the foundation.

#### **INDIRECT MEMBERS/INVISIBLE**

They are also known as shadow members they do not play active role in the activities of the organization but are expected to contribute resources on regular basis to support the operations of the organization. Management communicates and updates such members from time to time via sending them of reports, plan of actions, upcoming events, and correspondence to update them. They also have the free hand to come on board subject to official notification of management to perform other tasks if one wishes to do so.

**PARTNERSHIP MEMBERS:** These are organizations and coalitions who are by the virtue of our constitution are allowed to join the organization after meeting our standard of participation requirement. Such members become franchise members and it allows them to use our tools and resources from time to time to champion our cause in the common interest for mutual development. They are expected to benefit from our free trainings, workshops, consultancy, services, meetings, opportunities where necessary etc.

**BENEFICIARIES AND COMMUNITIES:** Whatever CAFAF does affect lives and our natural resources directly and indirectly which can be found in communities. Therefore these terms are used interchangeably to depict the nature of people and communities we operate in based on our resources.

**BENEFICIARIES:** They are our target audience who are reached with our range of interventions from time to time based on identification of their needs and wants.

#### COMMUNITIES

These are the geographical locations of our activities toward achieving our specific goals and mission. It changes depending on the projects and stakeholders and partnership activities. The entire structure of the organization uses either top to down or bottom to the top .its approach largely rests on the beneficiaries and communities for which reason we do not joke with them at all. The social marketing and donor supports received by the organization are directed to such areas to achieve the needed outcomes at the end of every intervention. Apart from this brief presentation on the governance structure, management has a pictorial view of the structure itself which can be referred to in our cooperate governance policy document .CAFAF have in place the necessary evidence which has been largely used, up dated to operate and conform to best practices and international standard from time to time. In 2014, further steps will be taken to update and review the policies to correspond with International and local demand standards in the field of NGOs operation.


#### Snap Short Of Our Achievement in -2021-2022

We have really touched lives and the numbers speak for it, bringing services to the most vulnerable in society throughout Ghana.

- 15000 people as beneficiaries of community outreach activities
- 3000 school children as beneficiaries of school free eye care screening activities
- 150 school children treated with drugs during eye health camps
- 5,650 children provided with free / subsidized spectacles
- 3,800 people reached through eye care ailment services
- 150 beneficiaries of subsidized cataract surgeries, (70 pro-poor patients)
- 150,000 people indirectly reached with eye health messages via social media, print, radio programs and general mass communication interventions

#### Date:-15<sup>TH</sup> DECEMBER 2021.

#### Venue:-PALADIUM –GERATER ACCRE REGION

Ghana has gone through the 3 stages of Covid -19 pandemic insurgencies and is in the 4 wave. With this in mind the team decided to create aware on the Covid -19 pandemic to community people before the 2021 Christmas.

The audiences educated were female group **(Agbaaa Jen Naa Women Group)** of 50 from the Palladium community of the Greater Accra Region in Ghana

The program started by distributing Nose mask to those who do not have it as at time of the program and again the events was on the awareness of coronavirus issues.

Before the training we **introduce the types of nose mask evolution.** The aim was to demonstrate what we improvised as nose mask before the imported ones was flooding the market;

**The talk started with:-**The message was conveyed by translation into a local Ga language of the people of the area.

<u>WHAT IS COVOD-19?-</u>The Corona virus is an illness ranging from the common cold to disease of severe attack of the body germs fighting immune System that prevents it from sickness.

**HOW IT IS SPREAD?** The Corona virus is transmitted from animals to human and from human to human through coughing, sneezing that spreads the virus from an infected person into the air around you. The Corona virus affects everybody. Men, women, children and the disable people anywhere.

HOW TO NOTICE THE CORONAVIRUS or (COVID -19)-Common sign of infection includes respiratory symptom, fever, dry cough, shortness of breath and Breathing difficulties.

The infection can cause:-Pneumonia, Severe acute Respiratory problems, Kidney failure and a quick death.



#### **BEFORE COVID-19 ADVICE**

1-Look carefully at where you are staying or Standing and keep the area clean from rubbish and waste materials.

2-Keep your CLOTHES AND COOKING UTENSILS NEAT.

3-Set up a **HAND WASHING STAND AT YOUR SCHOOL, HOME, CHURCH, MOSQUE AND ALWAYS USE A SANITIZER** for the hand cleaning.

4-If you feel feverish, coughing and are short of breath, Report to the Doctor at the nearest Hospital.

#### **DURING COVID-19 ADVICE**

1- Do **<u>NOT SHAKE HANDS</u>** to avoid getting the Virus.

- 2- Cover your mouth with a tissues or hanky when sneezing in public place,
- 3-keep a **ONE METER DISTANCE** from a person to person at public places.
- 4-Use SANITIZER if you do not have soap and running water at home or at work place.
- 5- Educate other people about the **<u>COVID-19</u>** virus to keep safe.
- 6- Clean and **DISINFECT** METAL AND WOOD SURFACE after use.
- 7-try to wear the **NOSE/FACE MASK** to cover your mouth and use gloves if you need to.



#### AFTER COVID-19 ADVICE

- 1- Continue NOT TO SHAKE HANDS unnecessarily.
- 2- Continue to COVER YOUR MOUTH WHEN SNEEZING in public place
- 3- Continue to keep a **ONE METER DISTANCING** from a person

4- Continue to use the **SANITIZER** if you do not have soap and running water home or at work place.

5- Continue TO EDUCATE OTHER PEOPLE about the COVID-19

Virus to keep safe.

6- Continue to CLEAN OR SANITIZE METAL AND WOOD SURFACE after use.

7-continue to wear THE NOSE/FACE MASK and mouth cover and use

Hand gloves if you have to.

Count Me In (CMI) is a consortium of regional and global networks of young key populations (YKPs) and young people living with HIV (YPLHIV), consisting of Y+ Global, Youth LEAD, and Youth RISE. Y+ Global has crucial experience working with country networks of young people living with HIV in the African region.

The main priority of CMI in the first grant cycle was capacity building, amplifying the participation and voices of young key populations in HIV in policy and decision-making processes, which produced tangible results.

Learning from previous experiences, the consortium is now shifting gears to CMI 2.0 to build, develop, and expand the amplification of YKPs voices in the Global Fund processes.

We work on strengthening the coordination of YPLHIV and YKPs to ensure that the design and implementation of those country-level strategies and programmes reflect their human rights, HIV,

and SRHR needs.

The key results achieved by the consortium were:

- Increased YKPs programs in Global Fund grants (Indonesia, Philippines)
- Increased number of YKP in CCMs (Mongolia, Vietnam, Malaysia)
- Recognition from CCMs for YPLHIV networks (Burundi, Zambia)
- Creation of new YKP networks (Georgia, South Africa) and,
- Overall increased engagement of YKPs and YPLHIV in all these countries at different levels

CMI 2.0 Project is funded by Community Rights and Gender Strategic Initiative grant and led by Youth LEAD, Y+ Global, and Youth RISE.







Home-grown solutions have popped up across Africa. In Ghana, for instance, a taxi driver fitted an automated hand washing machine on his car for passengers to use. In Kenya, nine-year-old Stephen Wamukota invented a hands-free washing facility that uses a foot-operated lever. The challenge now is to scale-up these and other innovations, and this is where public-private partnerships and funding incentives can play a key role.



What is true hand washing?

True. Washing your hands helps prevent a respiratory and diarrhoea-related illness, which, in turn, reduces the use of antibiotics that are often unnecessarily prescribed for these issues. Hand washing may also help prevent individuals from getting sick from germs that are already resistant to antibiotics.

# What are the 7 Steps of Hand Washing?

- 1. Step 1: Wet Hands. Wet your hands and apply enough liquid soap to create a good lather. ...
- 2. Step 2: Rub Palms Together. ...
- 3. Step 3: Rub the Back of Hands....
- 4. Step 4: Interlink Your Fingers. ...
- 5. Step 5: Cup Your Fingers. ...
- 6. Step 6: Clean the Thumbs. ...
- 7. Step 7: Rub Palms with Your Fingers.

Keeping hands clean can prevent 1 in 3 diarrheal illnesses and 1 in 5 respiratory infections, such as a cold or the flu. Each year on **October 15**, Global Hand washing Day highlights the importance of hand washing with soap and water at home, in the community, and



around the world.

COVID-19: Violence and neglect increases for older persons during lockdown, says UN expert

GENEVA (14 June 2021) - Violence, abuse and neglect of older persons have been brought into sharp focus during the COVID-19 pandemic.

To mark World Elder Abuse Awareness Day, Claudia Mahler, the Independent Expert on the enjoyment of all human rights of older persons, issues the following statement: "Distressing reports from care homes in different parts of the world showed neglect, isolation and lack of adequate services, including healthcare, social and legal services. Lockdown measures resulted in increases in gender-based violence and higher risks of violence, abuse and neglect of older persons confined with family members and caregivers.



Despite widespread alarm over the situation of older persons during the pandemic, the challenges and barriers to seek effective redress and remedies have received little attention. On the contrary, some disturbing practices were reported with care homes

being given immunity from civil liability for COVID-19 related deaths and putting in place contractual clauses that waive the right to file a court case and make arbitration the only option for alleged abuse or mistreatment. Elsewhere, older persons and their families expressed despair and frustration with the lack of transparency and responsiveness to complaints raised with aged care services providers.

These developments undermine older persons' access to justice and to an effective remedy. Older persons are rights holders whose dignity and rights do not have an expiration date in later life. Access to justice encompasses the right to a fair trial, equal access to and equality before the courts, and the right to seek and obtain just and timely remedies for human rights violations.

Entrenched ageist attitudes further hinder older persons from claiming their rights and undermine their autonomy to make their own choices and decisions. Lack of detailed information and analysis limits the possibility to reveal patterns of abuse which remain vastly under reported and determine the gaps in existing interventions, as well as to identify concrete action needed to provide adequate protection to older persons.



Older persons must not be left behind when seeking redress and remedies. I urge States to adopt a binding international human rights instrument, as well as national legislation and measures, to ensure access to justice for older persons with full respect of their autonomy. This should include the provision of legal aid, dedicated counselling and support services, diverse and age-appropriate formats to share information about rights and legal complaints mechanisms, reduction or exemption of litigation fees, and improved accessibility."

#### ADMINISTRATION

#### **BOARD MEETINGS**

A series of planned face to face meetings between management and the board could not come on formally as majority of them were always occupied with tough schedule most of the times including the covid-19 incidents . However, an informal meeting one on one took place where the executive director was able to brief majority of the members about what really is happening in terms of the foundations administration and to solicit their concerns as far as decision making and operations of the organization is concern. The office was always constantly in touch with them. Some have also given the green light for management to have them replaced by new crop of executives when the need arises at the pleasure of management. And so in 2016 critical steps will be taken to seal the loopholes created as far as decision taken at this highest level is concern.

#### **STAFF MEETINGS**

The executive Management Team met 20 times during the period. The meetings were used to discuss work program, job schedule of staff, effective and efficient ways of implementing cost free activities in 201-2023 and relatable partnership works. In addition to this effect the executive director had regular meetings with partners, friends of CAFAF, volunteers both online and off line. These meetings place management on top of the issues which prepare them to live up to the task fully. It brought a sigh of relief and the injection of new skills and strategies into the general administration of CAFAF as a whole.

## MOBILIZATION AND ADVOCACY

CAFAF beef up our mobilization and advocacy efforts which were are a corner stone to achieving our set targets. We largely used these platforms to communicate our cause both locally and internationally. Management exploited both partnerships, other institutions platforms to air our constructive views for policy reforms. These avenues include but not limited to



#### END OF YEAR REVIEW 2021-2022

As per the constitution and polices of CAFAF a regular yearly review meetings is expected to be held during which management present their performance and plan of action For the coming years , interact with members, volunteers partners, stakeholders and founders and the broader concern members of the public. Such decision is used again to interrogate the actions and interventions of the organization and offer suggestions to improve its performance.

In 2021 most of the practical approaches to things and suggestions made will be heavily injected into our mainstream of work and will be reviewed from time to time to know the efficacy of its experimentation. Increasingly efforts will be made to change the mode of work and working culture of members where the outputs of management will be measured with a balance score card scheme.

## FINANCE AND ADMINISTRATION

The general running of CAFAF during the period under review In terms of finance and administration suffered a lot of setbacks but with prudent strategic interventions management was duly able to salvage the image of the organization. The major source of funding for our activities was sourced from the internal fundraising. Greater chunk of our activities were delivered through partnership and voluntary schemes commitment from all. Management is still negotiating with other organizations and individuals to consider offering a regular donation into the coffers of the organization to enable it overcome most of the stresses associated with the administration of the organization financial wise. It is our fervent believe that the year 2016 will witness a different turn around which will help to spur the foundation to a higher heights.

# FUND RAISING, PROPOSAL SUBMISSION

Prudent management of any organization depends on key factors such as requisite human resource, capital and external factors of production. Such ingredients are pillars that fuel the growth and impacts of any entity failure of which no gains can be made. In the course of the year management exploited most tangible avenues of fundraising, proposal writing, and call for proposals and applied for them.

# PLAN OF ACTION FOR 2021-2023 AND ACTIVITIES

CAFAF is happy to have coined the 2015 programme of work (POA) from our strategic operation document that spans over a period of 2013- 2015. This is a 3 years' work plan of action and presents a bigger vision of the organization which seeks to measure the outputs of the organization and impacts made in our project communities. Thus for 2016 the following activities and interventions are planned to be delivered. These include but not limited to

- Climate change and environmental protection
- Communicable and non- communicable health education advocacy
- Youth for development
- Arts, cultural and music for development
- Human rights, peace, security, good governance
- Election 2024, Ghana for peace initiative
- ✤ Micro- Finance, financial inclusion etc

These broader headlines comes with a set of other key activities which are not covered here but are presented in the general framework which sets benchmarks for trading their implementation success (refer to our POA) for details on request. There aren't any available funds to run them but the POA provides a concrete clue of at least what mandate and target we have set for ourselves for delivery. This is also to make our communication and interaction with donors flexible, clear and results oriented. Proposal details are projects cost with its assented beneficiaries, and receiving communities will be communicated in our fundraising materials. Our POA is clear and will serve as a mirror of reflection and a compass to direct the entire operations of the year and avoid duplication of efforts in 2022.


