

COMMUNITY AND FAMILY AID FOUNDATION (NGO) is a Ghanaian National Non-Governmental Organization with a global thinking and acting locally, currently exclusively identified with promoting the empowerment of women, communities, young people to manage issues concerning their development and to advocate for and work towards adolescent and sexual reproductive health, rights and well-being; to advocate for and on behalf of young people, in the area of reproductive health, HIV/AIDS, environmental health education, climate change, and other related issues that affect their total development. Aim at hosting the largest effort of reaching out to youth of Ghana to appreciate and respond to their sexual health rights needs for a bright future and promoting their development toward the nations building.

CAFAF is registered under Registration Act 1963 No 21446 founded in 2006; the organization is also registered under the social welfare system DSW NO 3692. The work of CAFAF has spread over the entire Accra-region, has determined to organize the various programmes for the better livelihood, protection and sustainable development. CAFAF is working in the field of Integrated Rural Development, HIV/AIDS/maternal health, sexual reproductive health, promotion of Traditional Health System and Involvement and Advocacy for the social issues having a definite bearing on the life of people.

CAFAF has come forward with a strong faith that its efforts will uplift the socio economic condition of those people who have been neglected and denied for their rightful share of the society for centuries. The Organization work jointly with the people inviting them to participate actively in solving their own problems, The Organization support their reasonable demand and decision and encourage them to discover and utilize the available natural resources. CAFAF trusts that the spread of education will help them to overcome their deep rooted superstitions and social evils regarding emerging trends.

THE ANNUAL GENERAL MEETING

The Annual General Meeting (AGM) accordingly and by our constitution and policies remains the highest decision making body which looks into the overall operations and mandates of the organization. It is conveyed yearly and when the need arise equally tasked to meet for emergency to undertake critical decisions on key issues prevailing at the time. It brings together on one platform both dues and none paying dues members. This kind of encounter is set to review, act, and appraise the general performance of the management of the organization. Aftermath of satisfactory of the works of the management their contract is extended to another period agreed upon. Therefore the AGM is the heart beat of the foundation for which reason their decisions is central in the affairs of the organization.

EXECUTIVE MANAGEMENT

Beyond the operations of the AGM comes the executive management team led by a nucleus constituted set of expertise that are mandated to put the decisions of the AGM into action. They convey a series of meetings during which both financial and narrative activities reports ..are presented for thorough review by members. Thus, the executive management operates the organization for and on behalf of the members of the AGM. The chairman elected at the bi-annual AGM is expected to play active role and be the mouth piece of the AGM in the administration of the foundation all the time in the day to day running of the foundation.

Additionally, the Executive Director, is expected to expand the administration pattern of the organization and when necessary to make running of the secretariat smooth upon consultation with the chair person in the cause of time. The members of staff and volunteers is unlimited for which reason the Executive Director takes into accounts the available resources, needs, projects, situation vacant before recruiting people into the organization.

THE SECRETARIATE

The Secretariat is managed with the support of core staffs and the chairperson of the foundation. The Executive Director supervisors and coordinates all activities that take place from administration to other forms of engagement. Refer to our administrative documents for details. The secretariat is also mandated to venture into other key activities when necessary to the extent of having the power to open offices in other regions should the need be and where the resource for implementation of projects are available to do so.

INTERNATIONAL OFFICES: CAFAF by its constitution is free to operate foreign policy advocacy service across the globe. In this vain management is expected to follow the due processes in securing the necessary permits to operate at such levels. In 2013 quiet a number of people approached the foundation seeking permission to open similar offices outside the country to articulate the mission and vision of the foundation at such levels. Such permission has been granted to a group in Kenya and management is in constant touch with them supporting them to put the necessary structures in place. Outcomes of such engagement will be communicated into our next report in the coming years.

These offices are not to rub shoulders with the mother organization rather play complementary role in making the voice of people count through policy influence.

REGIONAL FOCAL POINT

CAFAF in the future hopes to operate in other regions in Ghana. As per our constitution management is in consultation with other Networks with possibility of opening office in a region that we are likely to begun implementing activities there. Such offices will be mined by regional representatives with core staff and volunteers where necessary. They will be expected to report to the regional office depending on the type of activities and projects offered on the grounds.

MEMBERSHIP: The organization recognizes two sets of members; they include direct and indirect members.

DIRECT MEMBERS: They are individuals and organizations who have interest in the organization. Such members pay dues and are engaged in most of the activities of the foundation as and when time will allow them. They are given specific tasks and targets to achieve which is supervise by a senior management member. These volunteers' members also represent the foundation at different levels of interaction and are mandated to raise funds to boost the operations of the foundation.

INDIRECT MEMBERS/INVISIBLE

They are also known as shadow members they do not play active role in the activities of the organization but are expected to contribute resources on regular basis to support the operations of the organization. Management communicates and updates such members from time to time via sending them of reports, plan of actions, upcoming events, correspondence to update them. They also have the free hand to come on board subject to official notification of management to perform other tasks if one wishes to do so.

PARTNERSHIP MEMBERS: These are organizations and coalitions who are by the virtue of our constitution are allowed to join the organization after meeting our standard of participation requirement. Such members become franchise members and it allows them to use our tools and resources from time to time to champion our cause in the common interest for mutual development. They are expected to benefit from our free trainings, workshops, consultancy, services, meetings, opportunities where necessary etc.

BENEFICIARIES AND COMMUNITIES: Whatever CAFAF does affect lives and our natural resources directly and indirectly which can be found in communities. Therefore these terms are used interchangeably to depict the nature of people and communities we operate in based on our resources.

BENEFICIARIES: They are our target audience who are reached with our range of interventions from time to time based on identification of their needs and wants.

COMMUNITIES

These are the geographical locations of our activities toward achieving our specific goals and mission. It changes depending on the projects and stakeholders and partnership activities. The entire structure of the organization uses either top to down or bottom to the top .its approach largely rests on the beneficiaries and communities for which reason we do not joke with them at all. The social marketing and donor supports received by the organization are directed to such areas to achieve the needed outcomes at the end of every intervention. Apart from this brief presentation on the governance structure, management has a pictorial view of the structure itself which can be referred to in our cooperate governance policy document .CAFAF have in place the necessary evidence which has been largely used, up dated to operate and conform to best practices and international standard from time to time. In 2014, further steps will be taken to up date and review the policies to correspond with International and local demand standards in the field of NGOs operation.



Ghana Diabetes Alert Campaign-Walking The Talk

KNOW YOUR RISK, KNOW YOUR RESPONSE

1 in 10 adults worldwide have diabetes. Over 90% have type 2 diabetes. Close to half are not yet diagnosed. In many cases, type 2 diabetes and its complications can be delayed or prevented by adopting and maintaining healthy habits. Knowing your risk and what to do is important to support prevention, early diagnosis and timely treatment.

Ghana is having a fair share of the Diabetes case on regular basis and report from the national diabetes programs calls for a rapid responses and contributions from all sectors. Community And Family Aid Foundation COMMITMENT TO MASS HEALTH EDUCATION AND AWARENESS CREATRION leaves much to be desired.

This has become a major concerns to put in efforts and complement government health institutions efforts in handling diabetes issues as a national health emergency .to this end our noble flagship project is a step up efforts of changing the narrative and fostering effective public engagement and awareness creation ,treatment,support ,cure,and advocacy for effective national resources mobilization to curb the incidence of diabetes on the national scope .

Abstract

People living with multimorbidity (PLWMM) have multiple needs and require long-term personalised care, which necessitates an integrated people-centred approach to healthcare. However, people-centred care may risk being a buzzword in global health and cannot be achieved unless we consider and prioritise the lived experience of the people themselves. This study captures the lived experiences of PLWMM in low- and middle-income countries (LMICs) by exploring their perspectives, experiences, and aspirations.

We analysed 50 semi-structured interview responses from 10 LMICs across three regions—South Asia, Latin America, and Western Africa—using an interpretative phenomenological analysis approach.

The bodily, social, and system experiences of illness by respondents were multidirectional and interactive, and largely captured the complexity of living with multimorbidity. Despite expensive treatments, many experienced little improvements in their conditions and felt that healthcare was not tailored to their needs. Disease management involved multiple and fragmented healthcare providers with lack of guidance, resulting in repetitive procedures, loss of time, confusion, and frustration. Financial burden was exacerbated by lost productivity and extreme finance coping strategies, creating a vicious cycle. Against the backdrop of uncertainty and disruption due to illness, many demonstrated an ability to cope with their conditions and navigate the healthcare system. Respondents' priorities were reflective of their desire to return to a pre-illness way of life—resuming work, caring for family, and maintaining a sense of independence and normalcy despite illness. Respondents had a wide

range of needs that required financial, health education, integrated care, and mental health support.

In discussion with respondents on outcomes, it appeared that many have complementary views about what is important and relevant, which may differ from the outcomes established by clinicians and researchers. This knowledge needs to complement and be incorporated into existing research and treatment models to ensure healthcare remains focused on the human and our evolving needs.

HERE IN GHANA

We researched and contacted grassroots organization in other parts of the world to explore about other potential stories for the series. All the leads to spoke about on the call seemed very interesting. We settled on the following organizations Gamashie Development Agency, the great thinkers -Solomon, Schools, ACT FOR Change, and finally selected Young visionary leaders Foundation

One of the stories that we explore WAS about pollution and access to water in Ghana. We have been researching trying to find community organizers' stories on this front. We are looking to contact people on the ground in Ghana that are advocating for change for the communities around them. We have been looking at stories related to plastic pollution and access to water, mainly, but we are open to other subjects like health, for example. Mainly, we are looking to reach out to a strong, boots on the ground, community organiser that could guide the audience through the documentary. The film will follow the work and story of this person, which will open the doors to other people in the community that are struggling with the issue through different angles.

Now after a series of consultation the production of the documentary team from UK arrived in Ghana at the early part of 2023 around January. They were 10 people in all. They spent 3 weeks on the grounds meeting stakeholders, including audiences for the documentary, issues to film and above all the crew for each sites both in the Volta region, Accra and among others.

What next

As at the end of December,2023 the tam at proper conveyed messages of assurances that the final products will be ready in 2024, and that they are still working and putting finishing touches to the documentary.

We at community and family aid foundation look forward to share the products with all in the coming months. We are happy to be associated with evidence based advocacy activities that will not only look at the short term impact but the long lasting efforts of not only demanding what is right in Ghana but across the globe of being part of the real time change makers.







Strengthening Systems for WASH in Healthcare Facilities in Ghana (Part II)

1. Background

WaterAid Ghana in collaboration with the Conrad N Hilton Foundation (CNHF) is implementing the Sustainable Water, Sanitation and Hygiene in Healthcare Facilities (WASH in HCFs) project to strengthen WASH and health systems, accelerating the coverage of reliable access to safer water and affordable, inclusive and sustainable WASH services within HCFs in Ghana.

The project aims to:

- 1. Develop the evidence base around safe water and WASH in HCFs to inform policy and practice.
- 2. Promote and enhance civil and social accountability for WASH in HCFs

Since the project's inception several studies and activities have been undertaken to guide implementation, key being the following:

i. Baseline and Policy Analysis

- ii. Budget Tracking and Analysis
- iii. Advocacy Strategy Development
- iv. WASH in HCFs Data Gathering and Development of WASH in HCFs models to support advocacy.

In line with the project's aim to ensure evidence generated is disseminated following validation of all findings at the district level, a national level dissemination is being organised. This Terms of Reference outlines the objectives, scope, deliverables, and timeline for learning and sharing workshop on the National Level Learning Alliance Platform.

2. Objectives

The main objective of the workshop is to share data and evidence gathered from project implementation so far and get feedback from key stakeholders including policy makers. The opportunity will also be used to influence policy makers on the need to prioritise and budget for WASH in health care facilities. UN General Assembly Formally Adopts Resolution on Political Declaration on Tuberculosis



The United Nations General Assembly has formally adopted by consensus the Political Declaration of the High-Level Meeting on the Fight against Tuberculosis. Member States discussed and adopted the Declaration through UN Resolution A/78/L.4, which is now

available in all UN languages. This follows the Declaration's adoption at the High-Level Meeting on TB on 22nd September. This critical step gives the Declaration the full endorsement and support of all UN Member States.

Our full 22nd September news alert on the Political Declaration is available below:

The Declaration contains the most ambitious targets to date in the fight against TB. If countries follow through on their commitments, it will put the world on track to ending TB by 2030 and providing life-saving treatment for 45 million people between 2023 and 2027.

Among key highlights, member states committed to providing life-saving treatment for up to 45 million people between 2023 and 2027, including up to 4.5 million children and up to 1.5 million people with drug-resistant tuberculosis; and to provide up to 45 million people with preventive treatment, including 30 million household contacts of people with tuberculosis, including children and 15 million people living with HIV.

Member states also committed to increasing annual global TB funding levels to over four times the current level (\$5.4 billion) towards reaching \$22 billion annually by 2027, increasing to \$35 billion by 2030. They agreed to mobilize this funding through domestic and international investment mechanisms, innovative financing mechanisms, and costed action plans.

Member states also committed to mobilize \$5 billion a year by 2027 for tuberculosis research and innovation - a five times increase from the current \$1 billion a year - towards the development of point of care diagnostics, vaccines for all forms of tuberculosis, and shorter, safer and more effective treatment regimens.

"This Declaration contains clear targets for the fight against TB. The TB community should be proud of their amazing work done to secure these targets. However, we know commitments alone aren't enough and Declarations will gather dust without further action. In 2018 member states promised to provide \$13 billion a year in annual TB funding by 2022, yet they're providing less than half that amount — who is accountable for the failure to follow through on this promise?", said Lucica Ditiu, Executive Director of the Stop TB Partnership. "This is why we need strong accountability efforts and tools to hold leaders and all of us accountable to reaching their promises. This starts with translating the global targets and commitments to national level, which Stop TB Partnership is currently working on, and ensuring civil society and TB communities have the resources and tools to ensure leaders follow through on their commitments."

Member states also made critical commitments to prioritize TB affected communities through agreement to create enabling legal and policy frameworks to combat inequality and eliminate TB-related discrimination, stigma and other human rights barriers, to ensure that the TB response is equitable, inclusive, people-centered and promotes gender equality and respects human rights including with regard to policymaking forums, planning, and comprehensive tuberculosis care delivery, and to increase and sustain investment for initiatives at the community level.

Unfortunately, member states failed to attach deadlines to these commitments which had been prioritized by TB-affected communities in their 'Deadly Divide' Accountability Report, and again featured in the interventions during the HLM itself. A small group of member states also opposed critical references to community-led monitoring and community, rights and gender action plans, which resulted in their removal during the negotiations process.

Member states failed to agree to several other key measures requested in the TB Community's <u>Key Asks document</u>, including a strong, robust, system of accountability in the Political Declaration to ensure regular and timely monitoring and follow-up, as well as weakened language on having a safe and effective new TB vaccine available in the next five years.

We would like to convey our congratulations to the High-Level Meeting co-facilitators, H.E. Mr. Krzysztof Szczerski, Permanent Representative of the Republic of Poland to the United Nations, and H.E. Mr. Bakhtiyor Ibragimov, former Permanent Representative of Uzbekistan to the United Nations, their teams, as well as the President of the 77th Session of the UN General Assembly, H.E. Csaba Korosi, and recognize their leadership and commitment towards this important step towards the adoption of the Declaration in the UN General Assembly in the coming weeks. We will share the adopted version Political Declaration when it's available.

Participation in World Bank Group Gender Strategy 2024-2030

The foundation was formally invited to participate fully in the , <u>World Bank Group Gender Strategy 2024-2030</u> consultation online. The formal consultation period for the draft <u>World Bank Group Gender Strategy 2024-2030</u> came to a close on November 30, 2023, thus, management was happy to share our rich expertise and experience.

From the informal dialogues beginning in January 2023 to the launch of the formal consultations in July at the Women Deliver Conference in Kigali, Rwanda:

We believe our support and willingness to connect us with our colleagues and partners yielded these positive outcomes. Our engagement enabled us to better understand diverse perspectives and listen to voices we may not always hear. Our work, the final Gender Strategy, and its implementation will be enriched by your generous, profound, and insightful inputs.

Before and the end

The WBG held country consultation missions in all regions, along with targeted in-person and on-line engagement in global fora with a wide range of stakeholders. Inputs were received from over 1,000 stakeholders from over 100 countries, representing more than 600 entities including civil society, government representatives, parliamentarians, academia, private sector, multilateral organizations, donors, and others. We will share some key takeaways that

emerged from these discussions with you in the coming weeks. The summaries of the consultations are also currently being published on the WBG Gender Strategy website.

In addition to the major inputs received on important topics, I am inspired by the people I've met and encouraged by their dedication, resolve and innovative ideas. From visiting adult education classes in an informal market outside Luanda, Angola and a kindergarten in the Kyrgyz Republic-- a women-led enterprise funded by support from the World Bank—to learning from the innovations led by women in poor villages in Gujarat, India such as biogas stoves and precision drip irrigation. I'm so grateful to those who shared their time and work.

In the weeks ahead, we hope to continue engaging with you as we finalize the Strategy for early 2024 and plan for its implementation. I hope that many of the connections we've made during the consultation process allow for greater and more impactful collaboration.

- 2. Ensuring equal access to healthcare, education, digital technology, affordable housing and food for all.
- 3. Extending debt relief for the least developed countries based on solidarity.
- 4. Ensuring equal access to a healthy and safe environment for all.
- 5. Ensuring that all persons are equal before the law without discrimination.

This is the time to rethink our whole approach to society, to accept and implement social change and transformation. Peoples' needs are changing in response to a quickly evolving context. People want more responsive action to address the key challenges. We need leadership to establish a renewed social contract integrating social, economic, environmental and political justice at both national and international levels.

Treatment Targets



8 December 2023, Geneva - Stop TB Partnership today released the estimated country shares of global targets committed in the political declaration of the United Nations High-Level Meeting (UNHLM) on TB, held in September 2023 at the United Nations General Assembly (UNGA) meeting. Amongst the commitments made during the UNGA were bold TB diagnosis, prevention, and treatment targets (numeric and percentages) to be achieved between 2023-2027.

These global-level targets cannot be achieved unless each country achieves its share. To support countries to plan for their share of the global target the Stop TB Partnership, working with partners, has disaggregated these global targets by country and by year, using a similar methodology as the Global Plan to End TB 2023-2030 and in full alignment with the End TB strategy and the WHO DG Flagship initiative. The document includes targets for treatment of TB, drug-resistant TB, children with TB, and TB preventive treatment for contacts and people living with HIV.

These targets are indicative, and the main purpose is to trigger country stakeholders and partners to set their own ones. Countries teams and stakeholders can reach out to

Stop TB Partnership for support or discussion if needed to understand and align the targets set for a specific country.

Lucica Ditiu, Executive Director of Stop TB Partnership said "The global targets on TB treatment and prevention set at the UNGA in September 2023 can be achieved if leaders and stakeholders of high TB burden countries understand their share of the global targets, set their own national and sub-national targets, and pursue them aggressively. Bold and clear targets will drive advocacy, action, and accountability. The country targets published by us today are our work to support countries in their effort to contribute to the achievement of the overall global ones."





THE HARARE HIV COMBINATION PREVENTION CASCADE

Towards a Regional Strategy to Drive Primary HIV Prevention?

In this session, our team from Zimbabwe will share our experiences as a country in developing and testing a novel 'Harare' HIV Combination Prevention Cascade for use in high-level monitoring and advocacy for the activities and resources needed to strengthen HIV prevention programmes. This generic cascade provides a unique summary of the overall coverage of all primary HIV prevention methods combined amongst those at risk and highlights where the main gaps are that need to be addressed to increase use. If measured and reported in national population surveys across the region, we believe this cascade could play a similar role to the treatment cascade in driving progress towards us all meeting UNAIDS' targets for 95% of people at risk to be using at least one method of primary HIV prevention and to reach zero new infections. In so doing, this will also serve to make ARV treatment programmes more sustainable.



In addition, we will share examples of how we have been using complementary methodspecific HIV prevention cascades – measured longitudinally, using data collected in routine programme records – to strengthen our local programmes.

New Global Status Report shows 2030 target is achievable but more investment in evidence-based actions needed to save lives

The Global Status Report on Road Safety 2023 was launched by WHO today. While progress has been made, the Global Alliance of NGOs for Road Safety (the Alliance) calls for greater investment in evidence-based interventions that put people at the center to halve road deaths and injuries and provide safe, affordable, accessible, sustainable mobility by 2030.

According to the report, 1.19 million people are killed on the world's roads every year, a decrease of 5% since 2010. In that time, 10 countries achieved at least a 50% reduction in road deaths and 85 achieved reductions between 10-49%, proving that the 2030 road safety targets are possible if governments invest in the right actions. The report notes that some of the greatest reductions were made "where the safe system approach – which puts people and safety at the core of mobility systems – was applied."

However, in 66 other countries, road deaths increased. The Alliance observes that too many governments are still not taking road safety seriously enough. The time for excuses is over. We call for stronger, more urgent action.

Governments must implement interventions that have been proven to save lives and reduce injuries

We know what works to reduce road deaths and injuries. These life-saving interventions must be scaled up. Only three countries reported having laws mandating national 30 km/h limits in urban areas where people and vehicles mix, and, while 160 countries reported having legislation on motorcycle-helmet use, only 54 of those meet WHO best practice.

Governments must allocate funding based on evidence and impact

Road crashes remain the leading cause of death for those aged 5–29 years old and 66% of those killed around the world are of working age, harming productivity and driving families into poverty. The global macroeconomic cost of road injuries is estimated in the report at US\$ 1.8 trillion — approximately 10–12% of global GDP. However, few countries are investing enough in road safety: 117 countries reported having a national road safety strategy but only 16 of them said they were fully funded. Most countries reported not knowing how the strategy was funded.

Governments must put people at the center of mobility

More than half of road deaths occur among pedestrians, cyclists, motorcyclists, and micro mobility users. The report shows how these at-risk groups are overlooked in road infrastructure: only 21% of assessed roads meet a minimum 3-star safety standard for pedestrians and only 0.2% of roads have cycle lanes. The report also warns that our car-centric mobility systems are unsustainable: the number of motorized vehicles on the world's roads has increased by 160% since 2010, and, with 60% of the global population expected to live in urban settings by 2030, "increased demand for mobility will exceed the capacity of most current systems."

Rethinking mobility to prioritize walking, cycling, and public transport is essential for people and the planet, tackling global crises of climate, health, and inequity. To make that shift, journeys must be safe for all road users.

The Alliance's Executive Director, Lotte Brondum, commented, "The data in the Global Status Report shows that halving road deaths by 2030 is possible but inaction is still letting people down, especially those who can least afford it. The report calls on civil society to 'generate evidence and hold leaders to account.' NGOs' role is to make these global numbers tangible and local, showing the reality of people's daily journeys, and to make sure that our decision makers act upon the findings we read today to halve road deaths and guarantee people's right to safe, affordable, accessible, sustainable mobility."
